The qualification of members of the Parish to vote for Vestry Persons and to vote on any issue at any meeting of the Parish shall be determined by an elections committee made up of the Rector and Senior and Junior Wardens. These persons shall be guided solely in their decisions by the provisions of Canon 2, Section 5 of the Canons of the Diocese of Western Michigan which require that they be baptized persons not less than sixteen years of age who, for a period of not less than six months preceding, shall have been regular worshipers in the parish, received Holy Communion at least three times over the past year and *bona fide* regular contributors to its support. By "*bona fide* regular contributors", it is understood that each Vestry member makes a pledge of their financial support to the Parish and fulfills that pledge to the best of their ability. St. Mark's Episcopal Church Minutes of the 182nd Annual Meeting (pages 7-11) January 27, 2019

Call to Order

Father Christian Brocato called the meeting to order at 12:16 pm.

Welcome and Opening Prayer

Father Christian opened the meeting in prayer. The congregation responded at appropriate intervals with full-throated Amens.

Nomination and Election of Secretary

Bruce Johnson nominated Andrew Knapp, the vestry clerk, to serve as secretary of the annual meeting, seconded by Rich Hiskes. The nomination passed unanimously.

Notification of Quorum and Robert's Rules of Order

Mark Stoppels, Esquire, reported that we have a quorum for the meeting. Father Christian announced that Mark Stoppels will enforce Robert's Rules of Order at the meeting.

Approval of Minutes of 2018 Annual Meeting

Jackie Taylor motioned to approve the minutes of the 2018 annual meeting, seconded by Anne Hiskes. The motion passed unanimously.

Reports for 2018

Rector's Report

Father Christian reported on our life together at St. Mark's. The staff of the parish stood and were applauded by the congregation. Father Christian asked everyone who volunteers and serves the parish in any way to stand, resulting in the majority of the attendees rising. Father Christian reported that some ministries have been flourishing and have tremendous internal cooperation, while other ministries require self-assessment and better cooperation. Father Christian requested that all ministries consider rotating the ministry chair every three years to encourage greater participation and discourage stagnation.

The parish continues to grow, though at a slower rate than in previous years. Every Sunday sees new visitors. We do need to improve how we respond to the growth, however—specifically with letting new members know how to be a part of the congregation through regular attendance and financial support. We had hoped to add a part time secretary to help with ministering to new parishioners, but the budget does not support the position, so Father Christian requested a volunteer to help with it.

Father Christian also requested someone to serve as a volunteer coordinator to help with recruiting assistance when necessary at points throughout the year.

Worship ministry meets regularly to discuss how St. Mark's can incorporate current worship styles while staying true to historic Anglican worship.

Attendance has been strong, especially on high holy days. Sunday attendance averages about 200 people. On Christmas Eve over 600 people attended between the two services. Father Christian acknowledged Gregory Crowell's work with our choral ministry. He exhorted the congregation to let the worship ministry know if parishioners' needs are not being met. The *Lift Every Voice and Sing* hymnal has increased our resources for hymnody. We continue to involve the youth in the parish more heavily in worship. Involving youth in as many ways as possible continues to be a priority for Father Christian and the children's formation team.

During 2018 we received numerous gifts from parishioners, which enabled us to do many things throughout the parish, from helping out with Breakfast Café to hanging our newly refurbished sanctuary light. Father Christian thanked Sandy Snellink and Linda Busman for help throughout the year with floral arrangements in the parish. This year we will have an additional offering once per quarter, specially designated for the Breakfast Café. This offering was approved by the vestry at the last monthly vestry meeting. Breakfast Café continues to flourish, having a wonderful impact on the community. Judy Freeman-Walker has done an excellent job soliciting grants for the ministry, and a newly created grants ministry now exists to help with the work.

There is also a new garden ministry, chaired by Marie McKendall. If people want to volunteer with the church garden in the spring, there will be opportunity.

Although we did not reach our pledge goal for 2019—which was a dream goal—we do have the highest amount pledged in the history of the parish. Also, every ministry submitted a budget, for the first time in memory. The number of pledges, though, dropped from 156 to 145 from 2018 to 2019, despite an increase in parishioners. Father Christian acknowledged Sharon Buursma and Pam Stevenson for their work creating the budget.

Father Christian exhorted the congregation to continue to volunteer in several ways around the parish. The strategic plan ministry did great work helping assess the various ministries. Father Christian acknowledged Catherine Frerichs for her work with strategic plan.

Father Christian pointed to our goals for building the parking lot into a parking garage and making other improvements to the property, including adding an elevator to help with accessibility.

St. Mark's continues to focus on praying for those on the parish prayer list. We do all that we can to include as many community members as possible in worship.

Father Christian acknowledged all those who participated in the chili lunch that accompanied the annual meeting. God blessed St. Mark's through 2018, and Father Christian thanked God and the congregation for everything over the past year. We move forward into 2019 committed to the gospel and God's grace.

Senior Warden's Report

Father Christian thanked Bruce Johnson for his work as senior warden this year, emphasizing Bruce's alacrity in responding to the abundance of email that accompanies the position. Bruce is concluding his three-year term as a vestry member and one-year term as senior warden. For Bruce's first vestry meeting as senior warden, the bishop joined to share his dream of building up the church's property with a new parking garage and other grandiose plans. This set the tone for 2018 being a year of large-scale vision.

Bruce acknowledged the congregation's commitment to the parish in so many ways, which will ensure the future health of the parish. He then acknowledged Father Christian, who has infused vitality and passion into the church in his two and a half years here.

Bruce recognized that the parish is doing well financially and acknowledged our treasurer, Sharon Buursma, and finance manager, Pam Stevenson. The church is (by choice) audited every year, and this is the first year that the audit came back completely clean, due to Sharon and Pam's tireless work.

Bruce thanked his fellow vestry folk who are rotating off: Nicolas Fletcher, John Slagter, and Briggitta Sartore (though Nicolas is standing for reelection on account of his youth and boundless energy).

Ministry Reports

We did not have oral reports from individual ministries because there are so many. Reports from all ministries are included in the 2018 Annual Report, which will go on file with the parish. Father Christian reminded the congregation that we are part of the Diocese of Western Michigan, who technically owns the property. He reported that we continue to be able to meet our significant fiduciary responsibility to the diocese, when many parishes are struggling to do so.

Dismantling Racism Vestry Charge

Father Christian acknowledged the volunteers on the dismantling racism ministry. Many parishes have such a ministry, but ours is the flagship one, and the diocese in many ways looks to the dismantling racism ministry at St. Mark's to see what should be done. Pursuant to the recent charge from the Diocese of Western Michigan to the dismantling racism ministries in various parishes, the vestry charged the St. Mark's dismantling racism ministry to establish a parish-wide plan for developing this ministry and bringing the entire parish into the duty of dismantling racism.

Qualifications for Voting

Father Christian read the qualifications for voting at the annual meeting (from the Revised Parish By-Laws, Constitution and Election of the Vestry, p. 2):

The qualification of members of the Parish to vote for Vestry Persons and to vote on any issue at any meeting of the Parish shall be determined by an elections committee made up of the Rector and Senior and Junior Wardens. These persons shall be guided solely in their decisions by the provisions of Canon 2, Section 5 of the Canons of the Diocese of Western Michigan which require that they be baptized persons not less than sixteen years of age who, for a period of not less than six months preceding, shall have been regular worshipers in the parish and *bona fide* regular contributors to its support. By "bona fide regular contributors," it is understood that each Vestry member makes a pledge of their financial support to the Parish and fulfills that pledge to the best of their ability. Martha Stoppels asked whether Nicolas Fletcher's reelection to the vestry accords with the parish's by-laws, which state that vestry members cannot succeed themselves. Father Christian responded that there is an exception here for when other vestry members have to leave the vestry before their term is up, and Nicolas is taking Briggitta's position.

Presentation and Approval of Revised By-Laws

In January 2019, the vestry voted to revise the parish's by-laws to make explicit the qualifications for vestry service, in accordance with the diocesan canons, and to modify the rector's listed responsibilities in line with the position's ministerial aims. Catherine Frerichs asked Father Christian to point to the specific changes to the bylaws, which he did. Father Christian explained his rationale for suggesting the change to the rector's responsibilities, which previously were mostly businesslike and made it seem like the ministerial aspects of the job were an afterthought. Rich Hiskes motioned that we approve the changes to the by-laws by acclamation, seconded by Jackie Taylor. The motion passed unanimously.

Vestry Matters: Acknowledgment of Vestry

The congregation acknowledged the four members of the vestry whose terms have expired or who will not be able to serve on the vestry moving forward: Bruce Johnson, Nicolas Fletcher, Briggitta Sartore, John Slagter. The congregation then acknowledged the eight vestry members who served in 2018 and will continue to serve in 2019: Sharon Buursma, Scot Gugle, Anne Hiskes, Dustin Hopkins, Michelle Jennings, Andrew Knapp, Chris Trevathan, Kenny Williams-Buck.

Introduction and Requirements of Nominees for Vestry

Father Christian read the requirements for vestry nominees, from the Revised Parish By-Laws, Constitution and Election of the Vestry, p. 2):

All nominations must have been received from an eligible member in good standing of the Parish. Nominees must be willing to serve, and their names must have been submitted "two weeks prior to the announced date of the Annual Meeting."

Appointment of Tellers, Presentation, and Election for New Vestry Members

Father Christian noted that the canons of the church say that the tellers should be submitted by ballot. Because we have four candidates for four positions, though, this seemed unnecessary. Rich Hiskes motioned that we accept the four candidates for vestry by popular acclamation, putting them on a single ballot which will be approved by the church secretary. David Messelink seconded the motion. Gloria Lara motioned to amend Rich's motion to point out that there are three new vestry members and one vestry member who has fulfilled his term but is standing for reelection to fill in for a member who must leave the vestry before her term is up. This motion was seconded by Chuck Bocskey and had no objections. The combined motion passed unanimously.

Catherine Frerichs pointed out that no women are joining the vestry, leaving the vestry with only two women [there are actually three]. Better decisions are made with a greater variety of voices. Father Christian responded that we do not have a surplus of volunteers to join the vestry, but we do hope to add a greater variety of voices in the coming years.

Father Christian confirmed that nominees for vestry must be communicants in good standing with the Episcopal Church, per the Qualifications for Voting and as defined by Title 1, Canon 17, Sections 2 and 3 of the General Convention of the Episcopal Church.

Father Christian presented the four nominees for new vestry persons: Mike Armour, Brandon Beyer, Nicolas Fletcher, Brian Topolewski. The four nominees were all confirmed by popular acclamation.

Diocesan Convention Delegates

Father Christian presented the six nominees for diocesan convention delegates. Consistent with the parish bylaws, the six nominees' names were presented to the congregation prior to the annual meeting and one is a warden of the parish. The six nominees are Jeff Brown, Michelle Jennings (junior warden), Gloria Lara, Bea Rocco, Cat Rogg, and Margaret Stretton.

Prayers for Parish Leadership

Father Christian led the congregation in a prayer for the vestry and all other members of parish leadership.

Financial Report.

Father Christian introduced Sharon Buursma, the treasurer for St. Mark's. Sharon acknowledged the members of the finance ministry before presenting the final 2018 report.

2018 was a good year for the parish financially. We had more cash available to pay bills in a timely manner than in previous years, as a result of the increase in pledges. We received a generous bequest that helped as well, without which we would have concluded the year in a much worse position. Sharon encouraged parishioners to include St. Mark's in their wills. We fixed several aspects of parish property that we had put off for years. We opened up the church to nonmembers for weddings and funerals, which should increase our income significantly. We have also added grants as a source of income for some ministries. Sharon acknowledged Judy Freeman-Walker's role in procuring grants. Ministries consistently came in under budget as well.

Mark Stoppels, former treasurer of St. Mark's, acknowledged that we are in a greatly improved position over former years. We have become much more disciplined against taking money from the endowment.

Chuck Bocskey acknowledged that we have experienced several blessings over the past few years, such as the big 2018 bequest.

Sharon presented the proposed 2019 budget, which is balanced (with a projected net income of \$3,082). All ministries will be held to their 2018 level, which should suffice since the ministries came in under budget last year. Rich Hiskes motioned that we approve the 2019 budget, with thanks, seconded by Mark Stoppels. The motion passed unanimously.

Father Christian informed the congregation that in future financial statements, the Breakfast Café will be pulled out of other parish financial statements. We are doing this to enable the grants ministry to solicit grants from institutions that will support the Breakfast Café as an individual entity but not as an arm of a church. Father Christian thanked the congregation for their financial support and encouraged us to continue to support the parish in prayer as well.

Closing Matters

The congregation sang "This Little Light of Mine" together, followed by a closing prayer led by Father Christian. Beth Hamm then motioned to adjourn the 182nd Annual Meeting of St. Mark's Episcopal Church, seconded by Judy Freeman-Walker. The motion passed unanimously. Deacon Jan Gockerman then dismissed the attendees. The congregation went forth into the world, rejoicing in the Spirit.

Rector's Annual Meeting Report for 2019 February 2, 2020 The Rev. Dr. Christian Brocato, Rector

Introduction

As the twentieth Rector of St. Mark's and on February 20 entering my fourth year of service as Rector, I hope we can all be proud that we continue to grow as a Parish, countering the statistics of many other churches. There are times of great surprise such as the Third Sunday of Advent when we had 260 adults and children in worship at St. Mark's. Christmas Eve saw some 575 adults and children who came to worship, give thanks and sing. Over the past year, we continued to do God's work even in the chaos of the world in which we, as Church, have found ourselves. We recognize that we minister in a broken world which needs the healing power of God's love.

Worship and Other Ministries: At St. Mark's, we continue to be faithful to beautiful and meaningful worship and sacred music for which we can all be proud. Dr. Greg Crowell and our Music Ministry continues to bring joy and delight every Sunday of the year. We give thanks to Greg and all those who bring music to our hearts and all those who participate in planning and executing beautiful worship, including Vergers, Assisting Ministers and Acolytes, Ushers and Greeters. I also give thanks for the ministry of Margaret Stretton and the Altar Guild, the behind the scenes volunteers who offer themselves week after week.

The host of ministries in our Ministry Directory demonstrates an amazing number of volunteer opportunities in a wide variety of areas. This year, we will add another ministry which will be devoted to environmental issues as we are charged to be stewards of God's Creation. Marie McKendall has proposed that ministry and will chair it. I give thanks for all the ministries of the Parish and especially the work of ministries which require participation every month of the year. Some say that we are stretched to the max, and that is more likely true than not. If you are involved in a ministry of any kind at St. Mark's, please, stand, if you will.

So many ministries require many helping hands and loving hearts, passionate about service to God and to others. We are grateful for all those who give of themselves so that all of us can experience the love of God in and through our life together at St. Mark's. Through it is always a question about highlight ministries, and I want to publicly offer thanks for all the ministries and the chairs of those ministries. Perhaps, parking might be a ministry in the future. For now, it seems that with the addition of the 210 Ionia Lot (Ellis) and the multiple level garage (GRCC) on Bostwick across from Fountain Street Church, both free, we are hearing few if any concerns about parking. I'm delighted to hear that and hope that that is indeed the case.

Judy Fetterhoff and Parish Life: Parish Life Ministry began its ministry in the 1990's. Today, I want to particularly acknowledge Judy Fetterhoff who helped found Parish Life Ministry in the 90's and has served as its Chair since then. Though Judy stepped down as Chair this fall, she will continue to serve in that important ministry of the Parish. Thank you, Judy, for so many years of faithful service! Please, accept this gift on behalf of the Parish for your long commitment to service here at St. Mark's.

Breakfast Café and the Breakfast Café Advisory Council: Our ministry to feed those in need continues to occupy a centerpiece in our outreach and serves on average 150 a hot breakfast every week. The Teams of volunteers faithfully prepare and serve alongside Monica Peak, Sexton, every Sunday. We are grateful to Jennifer Julius, Marissa Lee, Christiana de Groot, Darren Walhof and Cathy Stevens for ensuring that their teams work to accomplish this important ministry of the Parish.

This past year, we experienced a solid team of individuals, the Breakfast Café Advisory Council which brings in community partners. Along with our own volunteers, these partners include Westminster Presbyterian Church, Degage Ministries and Mel Trotter Ministries. We are grateful to all those now serving on the Council and the good work that is already being done.

Stewardship of Gifts at St. Mark's: I am very grateful for another year of record giving in financial stewardship, three years in which the growth of giving has been much appreciated. As of January 29, 2020, we have now received \$511,317 in pledged for 2020 in contrast to pledges of \$334,974 for 2017. This is a remarkable achievement for which I am most grateful. We recognize the need to increase the number of pledging members of the Parish to ensure vitality in giving, while we give thanks for this year's very successful Stewardship Season and its ministry, Shining Our Light. Many thanks, Roger York, and Stewardship Ministry team!

The oftentimes busyness of which we are about in many areas demonstrates a great deal of commitment of our staff and many parishioners for which I am very grateful. With now four full-time staff members and several part-time and non-paid staff, we continue to work hard to do all we can to tend the flock at St. Mark's. We are grateful for the financial resources which have enabled us to welcome Monica Peak as a full-time Sexton, much needed and much appreciated.

The true work of the Parish is about what we do to best ensure spiritual growth and development for all who gather at St. Mark's. I am attentive to that as all we do as a Parish is about being formed as disciples of Jesus. Part of what I do is to oversee, craft and present opportunities for Adult Christian Formation.

Formation and Spiritual Growth at St. Mark's: I have been in the process of reviewing Adult Formation activities and am now inviting parishioners to join me in an Adult Formation Ministry team. Three years ago, we expanded our offerings to include Wednesday formation opportunities in the fall, the winter, and in the spring, adding to the Lenten Series of many years. We have become more aware of the desire for more bible study opportunities and are working toward that end in Adult Formation.

I believe we can all be proud of the ministry of Jeff Brown as Director of Youth Formation and his ministry across the Diocese of Western Michigan. We can also be proud of the ministry of Laura Kozminski, Director of Children's Formation.

In July of 2019, Laura continued the successful ministry of Jane Stidolph when Jane resigned to embrace a teaching career in June of last year. In June, we celebrated Jane's ministry as we bid her farewell as Director of Children's Formation. Laura and the teams of volunteers now working in Children's Formation and Jeff in Youth Formation are blessing our young people with grace-filled opportunities to learn more about Jesus.

Last fall's Inquirers' Class and Youth Confirmation Class saw the preparation of twenty-two parishioners over a period of several months to be presented to the Bishop at the Confirmation Service at Diocesan Convention.

We can all be very proud of the commitment of those individuals to God and to St. Mark's.

If at the end of the day, we are not spiritually nourished and fed by God's Word, the Eucharist we share, the programs we offer and our life together in Jesus, then, we will not have been successful as a community of faith. If we do not work to end violence, bullying and racism in our midst, then, we are not being faithful to the Gospel which calls us to be people of peace, justice and mercy.

Over the past year, we rejoiced in welcoming a many new parishioners into our midst, parishioners of all ages, for whom we give many thanks. We bid farewell to several parishioners who went home to God or who moved away from St. Mark's.

We pause to remember and to give thanks for our parishioners who passed on to eternal life in 2019 and the parishioners who lost loved ones and friends this past year. For us here, we remember, Dr. Phyllis Danielson, William VanDerBos and Janet VanDeusen. We give thanks for them and ask God to comfort those who mourn.

Recognizing Our Humanity: This past year, we experienced several serious bumps in the road of our life together. Success in loving and caring for one another broke down in uncharted territory in ministry for me and some Parish leaders.

As we know, the Church is comprised of human beings capable of great good and capable of hurting one another. When the latter happens, we are called to be honest, seek forgiveness and work toward reconciliation.

I failed on several occasions over the past year in being pastorally sensitive, for which I have privately and in public asked for forgiveness. As a community of faith, we are called to forgive others as we seek to be forgiven.

If we are not a forgiving and reconciling community of faith, then, the message of the Gospel has yet to fully take root in our hearts. I call on each of us to look deep within to see ourselves as God sees us and invite God's love to bring healing and renewal in Jesus.

Safety at St. Marks's: A top priority for me as Rector is the safety of all those who come to St. Mark's. I am conscious of the need to provide as safe an environment as possible at St. Mark's. We are working diligently to put in place more measures to best ensure the safety of children, youth, adults, staff and all who find themselves at St. Mark's.

We are paying attention to statistical data which challenges us to be aware of the world around us, a nation which on average now experiences some 150 hate attacks on houses of worship across the country. This past week, the Vestry approved a new ministry, the Safety Ministry, and we have now completed the process of formatting a Safety Ministry Manual and policy document which will guide our efforts going forward.

Ministry in 2020: In 2020, we face challenges with mindful determination that we as Gospel people can and will make a difference. We believe that the love of Jesus is love given to us to embrace and to be poured out in all we do and say. We can also be proud of what we do as a community at worship and in all the ministries of the Parish.

As stewards of God's mission at St. Mark's, we work to tend those in need, those within our walls, our inbound parishioners, the sick, the elderly, those in need, and those on our city streets and elsewhere. Please, join in this prayer to God:

- May God be with us to help us to tend, to nourish and to feed.
- May God be with us to be people committed to justice, love and mercy.
- •May God continue to bless us with generous hearts and grant us the serenity to accept the things we cannot change, strength to change the things we can and the wisdom to know the difference during this year, 2020.

Thank you for your support and prayers and for your commitment to God and to St. Mark's. May God continue to bless us with the grace to do all we can to bring about God's reign here at St. Mark's. Thank you!

Breakfast Café

St. Mark's **Breakfast Cafe** continues as part of the Parish's outreach to the community and continues to serve on average of 150 neighbors every Sunday of the year. The five teams of individuals work to prepare, serve and help in the kitchen as they have done in the past. The on-going struggle of finding a permanent sexton/dishwasher continues but numerous volunteers have stepped up to be very helpful for which we are grateful.

A commitment to help save on costs has been facilitated by using Meijer gift cards and shopping with an eye on cost savings. The result has been that we have indeed saved money for which we are grateful. Volunteers continue to be needed, and if you are interested, please, let us know. The Breakfast Cafe is a very important part of our life at St. Mark's, and we are grateful for all the volunteers and support over the past year to continue this important work.

Christian Formation for Adults

Christian Formation for Children

In August of 2019 Laura Kozminski took on the position of Children's Ministry Director. September 8th was the start of a successful new program year. 4th through 6th graders began meeting for their Faith Formation class at 9:30 on Sundays. Communications Ministry

Communications continued improvement of communicating with our parishioners and the surrounding community. This past year, the Communications Ministry has increased the social media presence, engaging with the community. The Endowment Board operates from our Chart of Work which includes our purpose, objectives and schedule of work. We are governed by the St. Mark's Endowment Fund Trust Agreement dated July 1, 1997. Our investment manager is guided by our Investment Policy Statement. Meetings are held quarterly, including semi-annual investment update meetings with the investment manager. The spending policy allows for an annual distribution of 5% of the average market value of the endowment fund for the last 16 quarters. In 2019, the Endowment Fund provided \$44,693.91 in support of Church needs and operations.

Mission: Provide financial support for the needs and operations of the Church.

· Provide guidance for the investment and management of the St. Mark's Endowment Fund.

· Ensure maintenance of current and effective endowment policies and procedures

• Meet semi-annually with the investment manager for portfolio review and due diligence.

· Exercise oversight of distributions

• Ensure that decisions made regarding investments maximize protection and growth of the investments while being sensitive to the operating financial needs of St. Mark's

Endowment Fund balance: 12-31-2019: \$2,787,018.00

St. Mark's Endowment Funds are managed by JP Morgan Chase Private Bank. The return for the total portfolio in 2019 was a gain of 17.97%.

Frey Memorial Fund balance: 12-31-2019: \$453,452.48

This fund is held and invested by the Grand Rapids Community Foundation. The fund is not an asset of St. Mark's, however, the church is the sole beneficiary of the income, to be used as directed by the donor. No transfers to the Church were made in 2019 from this fund, although a 5% annual spending is allowed. The spendable balance accrues within the fund and as of 12-31-2019 was \$180,962,27.

Eucharist Bread Ministry

We continue to bake and offer two loafs of homemade bread for the 10:30 Service each week. However, in this last year we have committed to use a local heirloom wheat planted, grown and harvested at Plainsong Farm and stone ground off the grid in Traverse City. We have had two donors step up to purchase the wheat due to the fact that this new ministry request was not approved of for the 2019 budget. However, we are thrilled to learn that St. Mark's has agreed to purchase the flour this new year. The heirloom wheat has required some experimentation on the part of it's ability to absorb liquids and in baking. We continue to use the Society of St. John the Evangelist Monastery recipe supplied by Father Christian which results in a sweeter and moister loaf but have experienced some bumps in the road along the way with the bread being too thick or too dry. Bakers include Megan Harding, Karen Hunter, Michelle Jennings, Wendy Stock, Kristen Kopec, Dawn Buller and Dan McDonald. ~ Megan Harding

Eucharistic Ministers/Visitors Ministry

Eucharistic visitors provide a vital ministry for our congregation. They regularly visit and take Communion to our sick and homebound parishioners, connecting them to our community - the body of Christ. We currently have 3 Eucharistic visitors in addition to Fr. Christian and Mother Sue. One training for Eucharistic Ministers was held this year. Several people have expressed interest in becoming part of this ministry so we plan to hold a retreat and training in the spring. If you are interested in becoming part of this ministry please contact Deacon Jan.

Finance Ministry

Mission: The Mission of the *Finance Ministry* is to oversee the financial resources of the parish to enable St. Mark's to achieve its mission and vision. This work includes 1) oversight in developing annual operating and capital budgets for consideration by Vestry, 2) communication to Vestry regarding adherence to approved budgets, 3) assessing financial issues with recommendations to Vestry, 4) developing and maintaining financial internal controls, to policies and procedures that safeguard the financial resources to the highest financial standards, and 5) recommending an independent firm for the audit of parish accounts to Vestry and making any corrective action required.

Meetings: The Ministry met 10 times during 2019.

Accomplishments in 2019 included:

- Completed the 2020 Budget process that started in the summer in partnership with Vestry, the Stewardship Ministry, and other church ministries and staff. The Finance Ministry met to complete the 2020 budget and develop the 2020 budget three times for a total of over 9 hours.
- Completed a new policy for expenditures over \$500. The Rector and Finance Manager must authorize all reimbursable expenses of \$500 or over and sign approval of this expense request form in advance of purchase. This includes credit card purchases and includes Ministries & staff. Expenditures may only be made only if there exists an approved, unspent budget and such expenditures will not put the ministry or account over its approved annual budget.
- Recommended to Vestry the independent accounting firm of Monroe, Sweeris, & Tromp to conduct a financial audit for Fiscal Year 2018. The audit was completed in August and resulted in a favorable opinion by the auditor who reported that St. Mark's financial reporting, accounting systems, and internal controls are accurate for both Operations and Endowments. One-half of the audit cost is paid by the Endowment Board. There were no audit recommendations for management.

Many thanks to the Finance Ministry Team of volunteers and staff for their hard work, time, talent, and passion to build financial strength in support of God's work at St. Mark's Church and throughout our community. Respectfully submitted, ~ Pam Stevenson, Finance Manager

Garden Ministry

Grants Ministry

The Grants Ministry has been in existence for almost 2 years. Its primary focus has been to help the Breakfast Cafe become more self-sustaining and to provide assistance for building improvements and needed enhancements. Funding streams that have been acquired thus far include: Meijer, Inc., ACCESS, the Frey Foundation, Whittemore Foundation, the Cook Foundation and the Wege Foundation. The newly acquired Wege Foundation grant will provide St. Mark's a kitchen coordinator to assist with and oversee the wide range of kitchen uses and needs for the next two years. A good portion of this year has been preparation for some larger grant requests and cultivating relationships with the current funders. In February of this year we will learn if we will receive United Way support. This will provide more operating funding for the Cafe, safety and security training, program evaluation and other support that is needed to successfully run our outreach ministries. We have also been invited to reapply to the National Fund for Sacred Spaces for assistance in restoration and repair of our beautiful historic building. The larger grants we are working on require measurement of our outcomes and periodic reporting. St. Mark's is doing great things. Having grant partners and our reporting to them, helps the larger community be more aware of it. We appreciate those from the parish who have had connections to funders and have helped us secure some of the funding that we have already received. We ask others who have these connections to make us aware. Our ministry is only three women strong, so we could also use another member or two with grantsmanship skills to join us. Greeters Ministry

The Greeters Ministry was formed to greet and welcome parishioners and visitors to St. Mark's on Sunday mornings. Two people are scheduled at the 10:30 service – one at the back of the church and the other at the Parish Hall entrance – to greet people as they arrive and wish them well as they leave. We try to identify visitors, have them fill out contact information in one of the welcome books or on visitor cards, and invite them to social hour to meet more of the St. Mark's family. We also provide them with a welcome bag containing a St. Mark's coffee cup, history of St. Mark's and information about St. Mark's ministries. Human Resources Ministry

Recap for 2019: The Human Resource Ministry assists the Rector and the Vestry with recruiting, selection, compensation, and other HR functions as well as acting as a sounding board for the Rector and other Parish staff. Lectors and Intercessors Ministry

Liturgical Arts Ministry

Micah Project

For the last year and a half St. Mark's has been one of the lead congregations working with other Grand Rapids churches and organizations to build a broad-based organization committed to social justice in Grand Rapids. This new organization will have the power to enable systemic change for the benefit of all. In 2019, the Micah Project was officially designated as a Ministry at St. Mark's. Our core team within St. Mark's has done relational meetings with more than 150 parishioners. Forty-five St. Mark's members have attended one or more trainings in broad based organizing and three have attended a 5 day national training. We are continuing to develop relationships with other organizations that want to be part of this work for justice. ~ Deacon Jan Gockerman

Music Ministry

It has been an active and fulfilling year in music at St. Mark's.

The St. Dunstan's (Adult) Choir weekly enriches our weekly services with beautiful introits, anthems, and the chanting of the Psalms. Besides the excellent music making during Holy Week, Easter, Pentecost, Advent, and Christmas, the choir sang a Festival of Lessons and Carols and a Service of Choral Evensong as part of the Sacred Sounds at St. Mark's series. We welcomed a number of new choir members, such that the choir has grown to its largest size in years. All of last year's Choral Scholars stayed with us this year, and we added Erika Weinrick as a new member of our staff. Instrumental music was provided for Christmas and Easter, as well as occasionally throughout the year.

Brendan Hollins, who had served as our Organ Scholar for three years, had to leave us to accept a full-time position at Grand Valley State University. We will miss his exemplary musicianship, but we were very fortunate to welcome Noah Jacobs as our new Organ Scholar in September. Noah is an organ major at Hope College, and his excellent playing and hard work have already added a great deal to the worship life of St. Mark's. The St. Margaret's (Bell) Choir has played regularly for services throughout the year. We added new member Judy Coby, and new members are still needed.

Sacred Sounds at St. Mark's, our series of services and concerts, is now in its twelfth successful year. The 2018-2019 season continued with a stunning concert by the Michigan State University Chorale and a thrilling concert by Ensemble Florestan. Concerts this year include the acclaimed Ensemble Rebel from New York in February, soprano and instrumentalist Ruth Cunningham in March, and the award-winning choir Blue Heron in May. We continue to offer a diverse roster of performers and repertoire in accordance with our parish's outreach efforts. We were particularly proud that a performer on our 2017–2018 season, Jeannine De Bique, has since become one of the most sought-after performers in the world. She received great acclaim earlier this year for her performance in Mozart's The Marriage of Figaro at the San Francisco Opera. This was the first production by any major opera house to feature people of color in the starring roles. As in other years, Sacred Sounds donors were acknowledged at a dinner reception at Shiraz Restaurant in late summer, at which time the 2019-2020 season was

revealed.

A concert by the Imani Milele Children's Choir from Uganda originally planned for August 2019 fell through due to visa complications, and a new date has been set for Thursday, August 27, 2020 at 7:30 p.m. The musicians of St. Mark's continue to work closely with the Commission on Dismantling Racism and all of the Ministries of St. Mark's to strive for a deeper commitment to St. Mark's Mission Statement and to serving Christ in this church.

Strategic Planning Ministry

The Strategic Plan Ministry assists other ministries in focusing on their work. In two reports each year, they are asked to describe progress in working on one goal. Ministry members provide feedback on these reports. Studying these reports provides SPM with a broad perspective of St. Mark's.

In 2019, the Vestry agreed that the current parish-wide strategic plan, approved in 2017, should be updated to bridge the gap between the overall Mission and Vision of the parish and missions of individual ministries. As part of the preparation for this plan, the SPM sponsored eight focus groups during October. Fifty-eight people participated. They overwhelmingly identified St. Mark's welcoming, open atmosphere as the factor that most attracted them and keeps them here. They offered strong support for improving all aspects of accessibility. They expressed concerns about the budget, strengthening Adult Formation, and clarifying the mission of the Breakfast Café. The parish-wide plan will be completed in the first half of 2020.

-Combined Advent programming with St. Luke's Lutheran, as well as events with the dioceses of Michigan and Eastern Michigan and the Evangelical Lutheran Church in America (ELCA) of Michigan, allowed youth to make new and strengthen old connections.

-The Diocesan Progressive Mission Trip took us to parishes throughout Michigan, where we learned about and participated in outreach ministries near and dear to those parishes.

-Our youth each have a servant's heart and this was shown once again in their volunteering at "Soup's On for All", a fundraiser for God's Kitchen, and Breakfast Cafe at St. Mark's.

-Trips to Cedar Point, Craig's Cruisers, and Cran-Hill Ranch continued to be favorites.

-Oasis, our Wednesday night weekly meetup during the school year, continued with solid attendance, despite pressures from the outside activities many of our students are involved in. -Faith Lens from the ELCA, A Cosmic Adventure Through Science and Faith, and Life Transformed-The Way of Love in Lent and Journeying the Way of Love: Advent, both from the Episcopal Church, were some of the curriculums we used with great success. -We continued to be blessed by gifted adult volunteers who are called to this work with our youth.

-Several of our older youth made the mature commitment to go through confirmation studies this fall and be

confirmed by our bishop at Diocesan Convention.

What's ahead for 2020?

In addition to our traditional events, we are looking forward to more collaborations with our fellow Episcopal parishes in our region and diocese, as well as other dioceses. A highlight will surely be the triennial EYE in Washington D.C. in July.

Finance Manager Report to St. Mark's Parish As of December 31, 2019

There was financial progress at St. Mark's in 2019 as:

- * Cash was available to pay bills in a timely manner. This additional cash was due to increases in pledges during the 2019 pledge campaign.
- * \$7,200 was used from our Money Market (Savings) in December 2019 to help with cash flow. The \$7,200 was paid back to our Money Market (Savings) in January of 2020.
- * Received over \$50,000 in 2020 pre-paid pledges in November and December of 2019. This \$50,000 has to be shown as income on our income statement as cash received in 2019, but cannot be used for 2019. It is for use in 2020.
- * Total expenses of General Operations and the Breakfast Café Operations ended the year below the budgeted expenses which is very good. It shows that staff and volunteers are working hard to manage and utilize expenses as well as donations.
- * 5% of our Endowment Fund proceeds was used, as is the St. Mark's policy.

Thank you to all the parish donors, staff, and ministries as we worked together to achieve these financial results.

2020 Budget Summary

On behalf of Vestry, I am presenting the 2020 Budget that was approved at their January 28, 2020 meeting.

This 2020 Budget takes into consideration all known income and expenses, including the following:

- Our Stewardship Campaign, Shining Our Light, goal was \$525,000 in pledged giving for 2020 to go towards our operating budget of \$782,838. An additional \$17,500 for 2020 has been received from the Wege Foundation toward a part-time Kitchen Manager position.
- Currently we reached \$511,317 in pledges, received from 154 parishioners, for which we are very grateful.
- Our 2020 budget is not an "aspirational" goal, but is derived from the set needs of the important work and ministries of St. Mark's. The 2020 budget approved a hire of a full-time sexton and expenses towards the Micah Project.
- 2020 Total Net Income of \$9,135.49 for General Operations, Breakfast Café, Sacred Sounds & Endowment.

Memorials:

Memorials received during 2019 were in memory of Janet VanDeusen, William VanDerBos, Barbara Carduff and Phyllis Danielson, which were not designated for a specific purpose. The total memorials received in 2019 totaled \$2,547.97, which went to our general fund under memorial income. Bequests received with no designation (unrestricted), came from Kenneth and Christine Gilchrist for \$7,405.10, which was recorded under Bequests, in our general operations.

Endowment Fund:

5% Spending allocations for 2019 were \$128,081.37, which includes endowment for operations with a spending allocation of \$44,693.91; Sesqui building with a spending allocation of \$40,912.87; Sesqui outreach with a spending allocation of \$14,630.49; Minnema Music Fund with a spending allocation of \$26,433.56 and the Steam Easement Fund with a spending allocation of \$1,410.53.

Expenses paid towards the general operations of the budget in 2019 were \$44,693.91.

The total value of our investments as of December 31, 2019 is \$2,787,018.13 plus Frey Foundation \$453,452.48 for a total of \$3,240,470.61.

Sesqui Building Fund:

Spending allocations for 2019 were \$40,912.87, with an unspent balance left from 2018 of \$2,841.70, leaving the total spending allocation for 2019 of \$43,754.57. Expenses paid in 2019 were \$41,989.71, for maintenance and repairs, which had an expected life longer than one year to maintain the church building and property; bat control in the sanctuary; new HVAC Software; new gutters; new computers for Finance Manager and Music Director; Remodeling of first floor bathrooms; fence on south lawn. The remaining 2019 unspent allocation of \$1,764.86 will be carried forward to the 2020 spending allocation.

Sesqui Outreach Fund:

Spending allocations for 2019 were \$14,630.49, with an unspent balance left from 2018 of \$4,750.69, leaving the total spending allocation for 2019 \$19,381.18. The Outreach Ministry spent \$13,166.99, giving to organizations in the community such as; ACCESS (\$500), East Leonard Elementary School (\$705), Dwelling Place to support homelessness (\$2,400), Dwelling Place to support Transitional Housing (\$480), Heartside Ministry (\$1,200), Kids Food Basket (\$480), Safe Haven Ministries (\$1,600), Westminster Food Pantry (\$1,200), God's Kitchen (\$1,000), Arbor Circle (\$800), CASA (\$400), Explore and Soar Reading Program (\$1,252.50), Degage (\$1,149.49), Women's Spa Day, and Man Cave. The remaining 2019 unspent allocation of \$6,214.19will be carried forward to the 2020 spending allocation.

Minnema Music Fund:

Spending allocations for 2019 were \$26,433.56, with an unspent balance left from 2018 of \$10,049.78, leaving the total spending allocation for 2019 \$36,483.34. Expenses of \$22,885 were paid from the fund for choral and organ scholars. The remaining 2019 unspent allocation of \$13,598.34 will be carried forward to the 2020 spending allocation. Donations received in 20191 to supplement the Sacred Sounds Series were \$14,101.95.

Steam Easement Fund:

This reflects a yearly payment of \$7,500 from the Veolia Corporation, for easement connection with Grand Rapids Community College. This is a fifteen-year contract renewable with an escalator clause. These monies are set aside for HVAC replacement. In 2019 we were in need of a compressor for the air conditioner, so money was allocated to pay for our new compressor totaling \$5,175.50. Balance as of December 31, 2019 is \$3,366.01.

Frey Foundation Fund:

No monies were spent from Frey Foundation for 2019. Current balance as of December 31, 2019 is \$453,452.48. Spending balance as of December 31, 2019 is \$180,962.27.

Qualifications for Voting for Vestry:

Qualifications for Voting:

The qualification of members of the Parish to vote for Vestry Persons and to vote on any issue at any meeting of the Parish shall be determined by an elections committee made up of the Rector and Senior and Junior Wardens. These persons shall be guided solely in their decisions by the provisions of Canon 2, Section 5 of the Canons of the Diocese of Western Michigan which require that they be baptized persons not less than sixteen years of age who, for a period of not less than six months preceding, shall have been regular worshipers in the parish and *bona fide* regular contributors to its support. By "*bona fide* regular contributors", it is understood that each Vestry member makes a pledge of their financial support to the Parish and fulfills that pledge to the best of their ability.
